ORDER

Finding enough basis to proceed with the administrative investigation of this case, it appearing that the complaint is sufficient in form and substance and supported by evidence, **the above-named respondents** are hereby required to file their respective counter-affidavits and other controverting evidence to the said complaint, copy of which is hereto attached, within ten (10) days from receipt hereof in three (3) legible copies addressed to this Bureau through the Central Records Division, 2nd Floor, Ombudsman Bldg., Agham Road, Gov't Circle, North Triangle, Diliman, 1128 Quezon City furnishing the complainant with a copy thereof.

Respondents are hereby directed to **show cause** in their counter-affidavits **why they should not be placed under preventive suspension pending the conduct of formal administrative investigation.**

Respondents are likewise required to submit proof of service of their counter-affidavits/evidences to the complainant, who may file his reply-affidavit within an inextendible period of ten (10) days from receipt of the same.


